The meeting was called to order with roll call and pledge to flag.

Pat Mahaffey moved to adopt resolution #100407 to encumber funds for the 2008 street improvements. Copy enclosed. Dennis Nicodemus seconded the motion. All voted yes.

Pat Mahaffey moved to adopt resolution # 100407-1 employees retirement system. Copy enclosed. Dennis Nicodemus seconded the motion. All voted yes.

The September bank reconciliation was tabled.

Pat Mahaffey stated, “ This is the second public meeting of the EMS billing. Is there is any discussion?”. There were no questions.

Pat Mahaffey moved to allow the Township to establish the practice of charging a user fee for the emergency transport service for the Township of Truro, and establish a collection charge for such services.

Fiscal officer Nancy Schroyer reported she received bids from several banks for the purpose of opening a lock box for the deposit of money generated by the EMS billing.

Park National was the best price at \$60.00 per month flat fee with no other fees.

Pat Mahaffey moved to approve the fiscal officer pay the payroll of \$207,269.32 and bills of \$274,997.91. Dennis Nicodemus seconded the motion. All voted yes.

Pat Mahaffey moved to authorize the fiscal officer to pay the payroll and bills for October. Barb Strussion seconded the motion. All voted yes.
