The Truro Township Trustees held a regular meeting January 03,2007 at 6:10 pm. Present were Trustee Pat Mahaffey, Barbara Strussion Dennis Nicodemus. Fiscal officer Nancy Schroyer and Administrator Bob Stapleton.

The meeting was called to order with the pledge to the flag and roll call.

Barbara Strussion moved to approve the minutes from November 05,December 06 and special meeting December 18,2006. Dennis Nicodemus seconded the motion. All voted yes.

Chief Sharps reported runs for 2006 were 1,074 fire responses and 4,135 EMS responses for a total of 5,209. This was an average of 14.27 runs per day. Their were 18 structure fires totaling \$387,000.00, 7 vehicle fires for a total of \$13,000.00 and two other fires grass and mulch for a total of \$1,400.00. The total loss due to fire for 2006 was approximately \$401,000.00.

Chief Sharps requested that the Trustees approve the Lieutenants promotional list. The list will run from December 01,2006 until November 30,2008, a period of 2 Years. Pat Mahaffey so moved. Barbara Strussion seconded the motion. All voted yes.

Chief Sharps requested that the Trustees approve two updates section to the PPM. Section 3.6 and section 3.8. Pat Mahaffey so moved. Barbara Strussion seconded the motion. All voted yes.

Chief Sharps requested the Trustees approve Tuition reimbursement for Robert Schmidt, Shawn Lautner and Lt. Chase Bryan. Schmidt will be attending Franklin University for a BS in Fire Safety Administration. Lautner and Bryan will attend Columbus State for an associate Degree in Fire Science. Pat Mahaffey so moved. Dennis Nicodemus seconded the motion. All voted yes.

Chief Sharps reported the Eagles donated \$5,000.00 to the fire department. The money was put in the Safety House Account.

Chief Foltz reported that J.C. Penney donated \$1,000.00 to the Toys for Tots, Home Depot Gave \$6.00.00 which we purchase CO2 detectors to be given to the residents of Reynoldsburg. Chief Foltz will see that The Eagles, Penney's, Home Depot and All State will receive a plaque.

Superentant Larry Kaufman Introduced Stan Knoderer who will take over Larry's job, February 09 2006.

Pat Mahaffey approved September, October, and November bank statements.

Administrator Bob Stapleton reported that there were 220 kids taken care of in the Toys for Tots. Special thanks to Lt Mike Shirey, Lt Chase Bryan, Larry Kaufman, Bob Stapleton and Mary Burcham.

Barbara Strussion moved to accept Rumke trash extension of one-year extension at \$14.80 per month. Pat Mahaffey seconded the motion. All voted yes.

Barbara Strussion thanked all the people who worked on the Toys for Tots

All the Trustees thanked Larry Kaufman for all his hard work over the years.

Pat Mahaffey reported that the new firehouse would be handed over to the Township the 15 of January.

Pat Mahaffey approved the payroll of \$191,595.41 and bills of \$519,236.93 for December. Dennis Nicodemus seconded the motion. All voted yes.

Pat Mahaffey authorized the clerk to pay the bills for January 2007

The next meeting will be February 01,2007.
